8-Man-Tournament

Date: 20.02.2021

Location: Sporthalle Schlieren

Unterrohrstrasse 2, 8952 Schlieren, Schweiz

Tournament description:

In a tournament, 8 amateur fighters from one weight class will meet and fight for a place in the finals (September 25th, 2021, Basel) on February 20th 2021 in Schlieren. In the first part of the tournament on February 20th 2021, the respective fighters of a weight category fight in the quarter-finals and if they win and advance again in the semi-finals (1 to a maximum of 2 fights on the same day). The respective winners of the semi-finals will go to the final on September 25th 2021, where they will compete for the tournament victory, the SMMAC newcomer champion resp. the ISKA-Champion belt and win other lucrative prizes. Both MMA and K1 tournament fights are held in the amateur area. The tournament is suitable for amateur fighters who have already gained experience in the full contact area or who already have a few years of training / sparring experience and a good amateur level. However, professional fighters are not allowed to participate.

Weighin:

The Weighin will be on the same day of the fight (in the morning) and the tolerance is +1.5 kg for each weight class.

Travel & meals:

The event organizer does NOT reimburse the fighters for travel and meals. Each fighter is responsible for it by himself.

Registration:

MMA and K1 amateur fighters can register for the 8-Man-Tournament in their respective weight class by completely filling out the following form:

Important: The correctness of the information is essential for the correct assignment of the respective athlete. The information should be checked carefully before dispatch. When specifying point 6, it is important that all combat experiences in full contact martial arts (e.g. boxing, kickboxing, sambo, etc.) should be counted and reported. The information will be checked. If it turns out that a competing competitor has more combat experience than he stated, this can lead to sanctions and including complete exclusion from the tournament.

Further information will follow after registration through our matchmaker.

Please note: After the registration, we will confirm the fighters / trainers within a few days that we have received the form by email. It is therefore important that the email address given is correct if the registration is made using the internet form.

The **registration process ends on November 26th, 2020 at 2:00 p.m.** Please note that an early registration is recommended, as an 8-man tournament cannot be held in every existing weight class for reasons of time. Depending on the number of interested fighters, we will select the weight classes in which the 8-man tournament will be held.

Rules:

MMA: Unified Rules (Immaf) with GnP but without elbows and without twisted levers (e.g. without heel hook)

Fight and round time of the quarter final fight (1st fight) → 2 x 3 minutes (in the case of a tie where each fighter decides one round for himself, there will be an additional round of 3 minutes).

Fight and round time semi-final fight (2nd fight) → 3 x 3 min.

Protective equipment → MMA gloves 6oz (will be provided by the organizer), teeth protection, groin guard, only normal Thai / kickboxing bandages without structure (only slight stabilization with tape possible), real MMA or valetudo shorts without bags

and with naked upper body (except women), Vaseline will be put on in front of the fighting area by an official, do not use Thai / Tiger oil or any other substance to apply to the skin

K1: ISKA (B-Class) rules, with knee to the head

Fight and round time of the quarter-final fight (1st fight) → 2 x 2 minutes (in the case of a tie where each fighter decides one round for himself, there will be an additional round of 3 minutes).

Fight and round time of the semi-final fight (2nd fight) → 3 x 2 min.

Protective equipment → 10oz boxing gloves (will be provided by the organizer), teeth protection, groin guard, only ordinary Thai / kickboxing bandages without assembly (only slight stabilization with tape possible), real MMA or valetudo shorts without bags and with naked upper body (except women), petroleum jelly is required Applied to the fighting area by an official, Vaseline will be put on in front of the fighting area by an official, do not use Thai / Tiger oil or any other substance to apply to the skin

Prizes for the winners of the finals:

No fees are paid to the amateur fighters. Medals are awarded for 2nd and 3rd place. Prizes for the winners of the 8-man tournament are shown in the graphic below:
